As an independent contractor, BetterBkUSA agrees to do the following for the Attorney:

- Provide a BetterBkUSA “Client Intake Questionnaire” to Attorney for his/her client(s) to fill out.
- Enter the data from the “Client Intake Questionnaire” when received from Attorney, into Best Case bankruptcy software, version 17.
- Submit all requests for additional client information to Attorney.
- Forward a completed Petition “draft” via PDF format for Attorney’s review and final approval should no amendments be requested.
- Incorporate any amendments into Petition “draft” requested by Attorney.
- Forward a subsequent “draft” via PDF file format for Attorney’s final approval.
- Forward a ready-to-file Petition to Attorney via Best Case format or PDF.
- Return all data and documents to Attorney that was used to prepare the Petition.

The Attorney agrees to do the following for BetterBkUSA:

- Forward the fully completed “Client Intake Questionnaire” from his/her client.
- Forward copies of the last six (6) months of paycheck stubs for employed clients.
- Forward copies of the last six (6) months of bank statements for unemployed clients; or self-employed clients.
- Forward any additional information required from his/her client(s) to complete the Petition.
- Forward any amendments Attorney wants incorporated into the Petition “draft.”
- Review the Petition “drafts” forwarded to the Attorney, and if no amendments are required, to give his/her final approval.
- Provide a draft of “Plan” when Chapter 13 Petitions are involved.
- Forward updated information from client(s) if Means Test time limit has elapsed.
- Send the above items via priority mail or e-mail with attachments.

Cost of Document Preparation Services

- Chapter 7 Petition Prescreening only, for Means Test \$ 50
- Chapter 7 Petition (including prescreening) \$350
- Chapter 13 Petition \$450
- Petition “redo”(lapse of Means Test) \$100
- Other additional services on request (per hour) \$ 90

Payment for Services

- Payment is due in full when Attorney submits his/her final approval of a Petition “draft.”
- An invoice will accompany the first Petition “draft” to Attorney to expedite the forwarding of the ready-to-file Petition.
